WAIVER AND RELEASE OF LIABILITY**

**IN CONSIDERATION OF** the risk of injury that exists while participating in the MAYOR'S BAY SPRINGS BASS ROUND UP (hereinafter the "Activity"); and

IN CONSIDERATION OF my desire to participate in said Activity and being given the right to participate in the same;

I HEREBY, for myself, my heirs, executors, administrators, assigns, or personal representatives (hereinafter collectively "Releasor," "I" or "me", which terms shall also include Releasor's parents or guardian if Releasor is under 18 years of age), knowingly and voluntarily enter into this WAIVER AND RELEASE OF LIABILITY and hereby waive any and all rights, claims or causes of action of any kind arising out of my participation in the Activity; and

I HEREBY release and forever discharge BAY SPRINGS CHAMBER OF COMMERCE AND THE BROWN FAMILY (PROPERTY OWNERS), located in Bay Springs, Mississippi 39422, their affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors and assigns (collectively "Releasees"), from any physical or psychological injury that I may suffer as a direct result of my participation in the aforementioned Activity or any accidental injury caused to anyone by my participation in the aforementioned activity.

**I AM VOLUNTARILY PARTICIPATING IN THE AFOREMENTIONED ACTIVITY AND I AM PARTICIPATING IN THE ACTIVITY ENTIRELY AT MY OWN RISK. I AM AWARE OF THE RISKS ASSOCIATED WITH PARTICIPATING IN THIS ACTIVITY, WHICH MAY INCLUDE, BUT ARE NOT LIMITED TO: PHYSICAL OR PSYCHOLOGICAL INJURY, PAIN, SUFFERING, ILLNESS, DISFIGUREMENT, TEMPORARY OR PERMENENT DISABILITY (INCLUDING PARALYSIS), ECONOMIC OR EMOTIONAL LOSS, AND DEATH. I UNDERSTAND THAT THESE INJURIES OR OUTCOMES MAY ARISE FROM MY OWN OR OTHERS' NEGLIGENCE, CONDITIONS RELATED TO TRAVEL TO AND FROM THE ACTIVITY, OR FROM CONDITIONS AT THE ACTIVITY LOCATION(S). NONETHELESS, I ASSUME ALL RELEATED RISKS, BOTH KNOWN AND UNKNOWN TO ME, OF MY PARTICIPATION IN THIS ACTIVITY.**

I FURTHER AGREE to indemnify, defend, and hold harmless the Releasees against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney's Fees and any related costs.

I FURTHER ACKNOWLEDGE that Releasees are not responsible for errors, omissions, acts or failures to act of any party or entity conducting a specific event or activity on behalf of Releasees. In the event that I should require medical care or treatment, I authorize BAY SPRINGS CHAMBER OF COMMERCE AND THE BROWN FAMILY (PROPERTY OWNERS) to provide all emergency medical care deemed necessary, including but not limited to, first aid, CPR, the use of AEDs, emergency medical transport, and sharing of medical information with medical personnel. I further agree to assume all costs involved and agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

I FURTHER ACKNOWLEDGE that this Activity may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. I agree not to participate in the Activity unless I am medically able and properly trained, and I agree to abide by the decision of the Bay Springs Chamber of Commerce official or agent and the Brown Family (Property Owners), regarding my approval to participate in the Activity.

**I HEREBY ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS "WAIVER AND RELEASE" AND FULLY UNDERSTAND THAT IT IS A RELEASE OF LIABILITY. I EXPRESSLY AGREE TO RELEASE AND DISCHARGE BAY SPRINGS CHAMBER OF COMMERCE AND ALL OF ITS AFFILIATES, MANAGERS, MEMBERS, AGENTS, ATTORNEYS, STAFF, VOLUNTEERS, HEIRS, REPRESENTATIVES, PREDECESSORS, SUCCESSORS AND ASSIGNS, AND THE BROWN FAMILY (PROPERTY OWNER) FROM ANY AND ALL CLAIMS OR CAUSES OF ACTION AND I AGREE TO VOLUNTARILY GIVE UP OR WAIVE ANY RIGHT THAT I OTHERWISE HAVE TO BRING A LEGAL ACTION AGAINST BAY SPRINGS CHAMBER OF COMMERCE AND THE BROWN FAMILY (PROPERTY OWNER) FOR PERSONAL INJURY OR PROPERTY DAMAGE.**

To the extent that statute of case law does not prohibit releases for ordinary negligence, this release is also for such negligence on the part of BAY SPRINGS CHAMBER OF COMMERCE, its agents, and employees, and the BROWN FAMILY (PROPERTY OWNER).

I agree that this Release shall be governed for all purposes by Mississippi law, without regard to any conflict of law principles. This Release supersedes any and all previous oral or written promises or other agreements. In the event that any damage to equipment or

facilities occurs as a result of my or my family's or my agent's willful actions, neglect, or recklessness, I acknowledge and agree to be held liable for any and all costs associated with any such actions of neglect or recklessness.

THIS WAIVER AND RELEASE OF LIABILITY SHALL REMAIN IN EFFECT FOR THE DURATION OF MY PARTICIPATION IN THIS ACTIVITY, DURING THIS INITIAL AND ALL SUBSEQUENT EVENTS OF PARTICIPATION.

THIS AGREEMENT was entered into at arm's-length, without duress of coercion, and is to be interpreted as an agreement between two parties of equal bargaining strength. The participants and the BAY SPRINGS CHAMBER OF COMMERCE AND THE BROWN FAMILY (PROPERTY OWNER) agree that this agreement is clear and unambiguous as to its terms, and that no other evidence shall be used or admitted to alter or explain the terms of this agreement, but that it will be interpreted based on the language in accordance with the purposes for which it is entered into.

In the event that any provision contained within this Release of Liability shall be deemed to be severable or invalid, or if any term, condition, phrase or portion of this agreement shall be determined to be unlawful or otherwise unenforceable, the remainder of this agreement shall remain in full force and effect. If a court should find that any provision of this agreement to be invalid or unenforceable, but that by limiting said provision it would become valid and enforceable, then said provision shall be deemed to be written, construed and enforced as so limited.

The Mayor's Bay Springs Bass Round Up  
Rules and Regulations



1. The Mayor's Bay Springs Bass Round Up is June 20, 2026 Registration must be turned in at City Hall prior to the event.
2. The most bass fish caught under 15 inches wins. In the event of a tie, the winner will be determined by weight.
3. Any bass caught over 15 inches must be thrown back into the lake immediately.
4. The angler who turns the fish in must be the angler who caught the fish.  
You cannot combine your catches as a team. This is PER angler.
5. Each angler MUST register prior to fishing.
6. There are 3 angler divisions as follows:  
Kids: ages 6 to 9 years old  
Youth: ages 10 to 12 years old  
Adult: ages 13 and up
7. Adult supervision is required at all times for all contestants in the Kids and Youth Divisions.
8. All eligible fish must be caught by rod, reel, hook, and line only.
9. Anglers must supply their own bait.
10. Only one pole/rod in the water at a time per angler.
11. Anyone on the boat under age 12 is required to wear a life vest at all times while on the boat.
12. Children under age 12 must be accompanied by a responsible adult boat driver, age 16 or older.
13. Number of people allowed per boat is determined by your boat capacity listing.
14. There must be a life jacket on the boat for every person in your boat.
15. Only 15 boats will be allowed in the Lake.
16. Local fishermen will be given priority on boat entries.
17. Trolling motors is the only motor allowed.
18. Registration fees will be as follows:  
Children ages 6-12 may fish for free.  
\$25 angler fee per angler ages 13 and up  
\$50 boat fee
19. The competition will be judged per angler, not by boat.
20. All contestants, adult supervisors, and spectators must show good sportsmanship and "play" a fair game.
21. At the end of the tournament, anglers should not leave any litter, bait, fishing line, etc. in your area.
22. All people entering Lake Charles/the Brown property must sign a release. This includes spectators.
